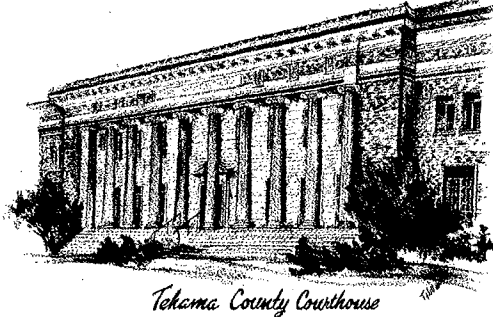

TEHAMA COUNTY SHERIFF'S OFFICE SPECIFICATIONS

General Armor Specifications:

Threat level IIIA

Soft Armor: Must meet or exceed weight and ballistic capability of Point Blank AXBIIIA armor.

Rifle Plates: Must meet or exceed weight and ballistic capability of Paraclete Omega 10x12 plates.

*Ballistic components must be warranted by manufacturer for a period of **FIVE YEARS** or greater.

General Carrier Specifications:

- Carrier must be Black or Ranger Green
- Carrier must be adjustable in shoulders and cummerbund
- Carrier must be IIIA material, capable of housing two 10x12 rifle plates (front and rear).
- Carrier/Vest must be scalable with removable IIIA ballistic protection in the following areas: Neck, Shoulder, Throat and Groin.
- Carrier must be integrated with a laser cut molle attachment system.
- Carrier must incorporate First Spear Tubes™ Rapid-Release Technology for shoulder and side closures.
- Carrier must incorporate comfort padding through body and shoulder straps.
- Carrier must incorporate Built-in ventilation channel on front and rear plate bag.
- Carrier must incorporate a soft armored, overlap cummerbund, with loop interior for hook backed pockets.
- Carrier must be capable of fitting a variety of plate cuts.
- Carrier must incorporate a **lifetime warranty** of non-ballistic components with no end-user cost for repairs or replacement.
